SPECIAL OFFER:

If you are not eligible for 30 hours free childcare per week, but wish your child to attend both morning and afternoon sessions, the daily cost for this is £25. If you want your child to do this every ay within a week then the weekly charge for 5 days will be just £100, saving you £25.

How do you know if you are eligible for 30 hours of free child care?

You may be eligible for 30 hours of free childcare if your circumstances are as follows:

Both parents are earning or expect to earn the equivalent to 16 hours at National Minimum or Living Wage over the coming three months

£2,167 if you're aged 23 or over

£2,117 if you're aged 21 or 22

£1,557 if you're aged 18 to 20

£1,098 if you're under 18 or an apprentice

- Where one or both parents are on maternity, paternity, shared parental or adoption leave, or if they are on statutory sick leave
- Where one parent meets the income criteria and the other is unable to work because they are disabled, have caring responsibilities or have been assessed as having limited capability to work
